# TERMS OF USE

## EDUCATIONAL VIDEO ON HEALTHY WEIGHT / VERSION FOR DIETITIANS

Any person authorized («User») by Dairy Farmers of Canada («DFC») to broadcast the educational video on healthy weight / version for dietitians («Video»), the duration of which is approximately 8 minutes in French and 8 minutes in English, must comply with the terms of use described below («Terms and Conditions»).

1. The Video must be ordered and broadcast only by a dietitian who is member in good standing of an association or college of Dietitians in a Canadian province;
2. The Video must be broadcast only in Canada, in the workplace identified on the Video Order Form returned to DFC;
3. The Video must be broadcast in full. It may be broadcast either in French, English or both languages. Users have the responsibility of ensuring that the Video is broadcast in accordance with any language laws that may apply in the broadcast area;
4. The Video can not be modified or reproduced either in part or in full on any support media or in any media whatsoever. Users can not lend or rent the Video to another person, or authorize its broadcast by another person;
5. DFC reserves the right to require Users to cease broadcast of the Video at any time and for any reason whatsoever, by sending a written notice to this effect;
6. The Video is the exclusive property of DFC. Users agree not to use or reproduce trademarks owned by DFC or any other person appearing in the Video, or any text used in the Video;
7. Users are responsible for any rights, costs or other charges that could be required to pay to broadcast the Video in the workplace or in any other place where the Video could be broadcast with the agreement of DFC;
8. Users agree not to denigrate the content of the Video, or take any action, or cause any situation in connection with the Video that could cause prejudice to DFC or its image.
